<p>Violation #48. Ware washing: installed, maintained, & used; test strips Observed wet towels in air drying table beside three compartment sink. Remove towels from air drying table beside three compartment sink. Operator removed. COS.</p> <p>CODE REFERENCE: 64E-11.003(4). Warewashing facilities must be approved, available, maintained, effective, and used for cleaning and sanitizing food-contact surfaces and equipment. Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.</p>
<p>Violation #54. Garbage & refuse disposal Observed dumpster with lids opened. Close dumpsters lids.</p> <p>CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
<p>Violation #55. Facilities installed, maintained, & clean Observed kitchen ceiling tiles not smooth/easy cleanable and soiled. Replace kitchen ceiling tiles by smooth, durable, easy cleanable and non-absorbent tiles.</p> <p>CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
